

#### My Mac Updates By Lou Cioccio at Computer Users of Erie

Wow, the Apple does move and advance as we have all seen from iPhones, iPads and Macs. Now we are left with old hardware so what should we do?

Most Macs seem to run well even though not supported. You could keep the Mac running a particular software and Operating system to your advantage and transferring the file to the newer Mac. An example would be a graphic image done in Aperture, an orphaned Apple product, and finishing it up in a newer piece of software.

You could do this by sneaker, net, or setting up your home network to transfer files. You just have to be aware that the old computer should never go out to the web, as security updates are no longer supported by Apple, and that goes for Windows users also.

So, I have this old 2010 dual CPU with 32 GB RAM and 4 solid state hard drives. The newest software that it could run was unsupported Mojave, but I did buy a "Metal" capable flashed to Mac Video card before they skyrocket in price!!!

I used DOSDUDE1 patcher and it performs well.

Now I did pick up a new OLD monitor, an Apple Thunderbolt 27 inch Studio, for \$285, a grade A type that worked fine on my USB dock, plus its Thunderbolt and Display connector. The USB to ethernet would work but whenever I had updates on Monterey, I would have to do the re-install dance; sometimes it would work, and other times, not, so I ended getting a thunderbolt to ethernet adapter that would work. I no longer need that dongle as the Apple Studio Thunderbolt to Ethernet port works through the monitor display!!!

I am still looking at the 2010 Cheesegrater Pro Tower and decided to use Open Core and install Big Sur OS for the Mac. You will want to print out the instructions, and reread them several times, so that you get familiar with the instructions without going down the rabbit hole like I did!

SIP (System Integrity Protection) has to be disabled using Open Core and you do that in restore mode and in Terminal with the command line "csrutil disable". Then you can install Open Core which is quite novel and much easier than creating a Hackintosh that I have been familiar with.

You will have to create a bootable open core USB stick, out of at least 16 GB in size, and it may take 30 minutes to create, as it will install the OS from the Apple Servers without going to the App Store!!! This makes life easier for YOU!

So, I was able to get BIG Sur running on my 2010 CMP (Cheesegrater Mac Pro) and it is working fine. It will boot up on its own but if I want another drive to boot up, I will need to hold the Option key and pick the drive since Open Core has its own UEFI (the root of trust for the UEFI firmware is the chip where the firmware is stored). UEFI firmware updates are digitally signed by Apple).

My next project is updating my 2012 iMac by replacing the mechanical drive with a 2TB SSD and using Open Core to make it last a little longer. Like the old Bob Wills tune "You dance with the one who brung ya."

### Scam Phone Calls Don't Have to Drive You Crazy

Years from now, when future generations look back on this era, they'll probably shake their heads and wonder about all the bothersome phone calls many of us receive and wonder why we put up with this nonsense.

While there is no silver bullet, you can block most of these calls by using software designed to block annoying robocalls, telemarketers, and phone scams.

You install the software on your iPhone or Android phone.

If you use a landline phone that receives calls using the Internet (called VoIP), many of these same products offer websites where you can tell your Internet provider to block unwanted calls.

The tech site, Mashable (mashable.com), lists seven of what it calls "The best robocall blocking apps and tools for avoiding phone spam." In other words, "Your jig is up, unknown caller!"

Here are Mashable's Top 7 Picks:

• Best Free App: Hiya – Caller ID & Spam Blocker (www.hiya.com)

• Best Paid App: Nomorobo Robocall Blocking (www.nomorobo.com)

• Best For Getting Revenge on Scammers: RoboKiller – Spam Call Blocker (www.robokiller.com)

• Best For Businesses: YouMail Voicemail and Spam Block (www.youmail.com)

• Best For Landlines: Call Control Home (www.callcontrol.com)

• Best For Number Lookups: Truecaller (www.truecaller.com)

• Best For Unmasking Calls: TrapCall – Reveal No Caller ID (www.trapcall.com)

The Mashable writer begins, "If there's one thing people with iPhones and Android phones can agree on, it's this: Robocalls suck. Although, personally speaking, robots call me more than my mother does..."

"At present, robocalls are the No. 1 source of consumer complaints to the FCC, making up 60% of all filings... Anyone can run a phone scan nowadays; one Florida man managed to place 96 million robocalls all by himself over three months in 2016 before the government cracked down on his shenanigans," adds Mashable.

What I find scary is that in 2020 one in six Americans fell prey to scams, up from one in ten in 2017. The call-blocking company, Truecaller, discovered that each victim reported an average loss of \$244.

Ouch. "Installing a third-party robocall blocking app remains one of the best and most reliable ways to prevent robocallers, telemarketers, and even pesky political campaigns from reaching you on your smartphone. (Be sure to do your due diligence and pore over its privacy policy first, so you know exactly what you're signing up for.)." writes Mashable.


### Scam Phone Calls Continued

A couple of CKCS members asked me what I use, and I mentioned Nomorobo. I use it on my iPhone and Ooma, the landline phone service at home (that's what CKCS uses at the office.)

Nomorobo got its start in 2012 when the Federal Trade Commission put out a challenge. What became Nomorobo tied for the best overall solution, winning a \$25,000 prize. You can download the smartphone app from the various app stores (\$1.99 per month, per device) or register for the landline service (free) from the Nomorobo website. Scroll down, and you'll see Landlines and Mobile displayed at the bottom of the page.

As I type this on a rainy Monday afternoon, Nomorobo is currently blocking more than 4.6 million scam phone calls. I got two scam phone calls this morning while walking in a park near my home. Nomorobo did its job – silencing both calls, so they never bothered me, and one went directly to voicemail trying to sell me an extended car warranty (one of the most pervasive and hated robocalls.)

Here is the Nomorobo app as it appears on my iPhone. If I get a possible scam call that is not in Nomorobo's database, I have the option of sending the phone number through the app to the Nomorobo staff for it to confirm it's bogus and add it to the giant database.

### Genealogy Report for 11/1/22 SIG Meeting

The Genealogy SIG Held its November meeting via Zoon beginning at 7:00 pm on November 1st. Fifteen were in attendance.

Sue reviewed Ancestry's new SideView which divides your DNA ethnicity in two categories: Parent 1 and Parent 2. If your parents came from diverse ethnic backgrounds, you can identify and label which belongs to your paternal and maternal side. Sue showed a video on this subject by popular You Tube genealogy host Andy Lee of Family History Fanatics (https://www.youtube.com/watch?v=Ez0w g\_JcjC0).

In the video, Andy reviews the process and value of this new tool. He also relates that he took a second Ancestry DNA test using a fake name and received <u>slightly</u> different results from his original test. That brought up discussion by members who have questioned their ethnicity results.


Carl Z. had great success using the Erie Public Library's eDatabases (https://erielibrary.org/) to search for obituaries. While it is a somewhat lengthy process, Carl found 43 obituaries with the surname he was searching. He read each one and found a relative in Buffalo, NY that didn't know. He also suggested checking funeral home records when doing your research.

The question of how to list people in your family tree when the surname has numerous spellings came up. Names can change as they were Americanized, families moved, or for other reasons. Sue's opinion was to spell it how that particular ancestor used it.

Well known genealogist and DNA expert, Diahan Southhard, will be hosting a new television show called Your DNA Secrets Revealed on PBS. It is scheduled to air on November 26th and 29th at 11:00 pm on WQLN. The show doesn't just focus on the moment you receive your DNA results but also looks at how this information affects families.

### Smartphone & Tablet Report for 11/28/22 SIG Meeting

We started this meeting with general topics. Is your phone listening to you? Has your phone has been hacked? What do you do when an app is not responding or when your device is not behaving as it should? Four short videos covered these topics.


Apple released several operating system updates since our last meeting. We reviewed iOS 16.1 and iOS 16.1.1 and briefly talked about iPadOS 16.1. The Contacts app has several new features. Duplicate contacts are identified and can be merged. You now have total control over contact groups as you can create, delete and rename groups across accounts. These groups can be used to send emails or messages to all in the group. Another significant feature is the ability to control how much information from the Contact care is transmitted when you want to share a contact with another person.

Siri was another topic for discussion as the AI that underlies the voice assistant continues to expand. Most of the features added to the Siri voice assistant are incremental such as using Siri to end a phone call, adjusting the pause time before Siri executes your command and improvements to the dictation capability.

We looked at video clips on new Apple Maps features, new capabilities of Weather in iPadOS 16.1, iCloud Share Photo Library and Visual Look Up in the Photos app and Rapid Security Response. RSR is an update system that pushes security updates more quickly than system updates usually occur.

There will be no meeting of this SIG Group in December since our customary date is the day after Christmas. See you in January.


### Directions to Wayside Presbyterian Church for CUE Meetings

Wayside Presbyterian Church, at 1208 Asbury Road, is approximately three blocks north of the intersection of Asbury Road and Route 5. This intersection is at the northwest corner of the Erie International Airport property. Following Asbury, turn left at the first marked driveway for the church. During the afternoon winter schedule (10:00 AM for the months of November, January, February and March), entry is through the two sets of blue double doors. Use the buzzer to gain entry if the doors are locked. During the normal evening schedule (7:00 PM the remaining months) use the double doors on the south side of the Christian Education wing. Signs are posted in the building to direct you to the meeting room.

From West of Erie International Airport: Follow Route 5 to the intersection of Asbury and Route 5. Turn hard left onto Asbury Road. Look for the church on the left approximately 3 blocks north of the intersection.

From South of Erie: Take Interstate 79 north to the 26th Street (Route 20) Exit. Bear left onto 26th Street (Route 20) west. Follow Route 20 about 3.4 miles west to Asbury Road. Turn right (at the Sheetz Gas Station) onto Asbury and follow it straight across Route 5. Look for the church on the left approximately 3 blocks north of the intersection.

From East of Erie International Airport: Follow 26th Street (Route 20) west to Asbury Road. Turn right onto Asbury and follow it straight across Route 5. Look for the church on the left approximately 3 blocks north of the intersection. OR, follow 12th Street (Route 5) west past the airport to Asbury Road. Turn right onto Asbury Road. Look for the church on the left approximately 3 blocks north of the intersection.
