


November CUE Meeting

The New CUE Website!

When you picked up your first computer or smartphone or tablet, the sales person never told you about how fast things change. CUE has been around for over thirty-seven years. CUE has changed since then. There is now one more change and I promise you it is easy.

I hope that you join me when I explain this change at the next monthly CUE meeting. Join me at 10 AM on November 21, 2019.

One more thing. Please, if you have not already registered, register before hand so you can get the most benefit.

It starts here: http://cue.communitysite.com or simply cue.communitysite.com

Do not use the WWW as before. (This address may change in the future)

As a CUE member, you will need to REGISTER. It is a simple procedure and helps CUE verify that you are, in fact, a CUE member and not an outside observer. When you get confirmation that you are a CUE member you need to log into the site using the information you used to register.

As a REGISTERED CUE member you will then have access to private useful pages designed for our members.



You REGISTER by clicking on the register in the upper right hand corner of the Home screen. See the arrow pointers.

You then need to supply the requested information. You will need to submit it by pressing the REGISTER button. You will receive an email letting you know that your information is being submitted for review. Once you are verified you will receive an email letting you know that you are approved or disapproved. It's that simple.

Then log into the new site with your own personal log on information you just created.

When using a mobile device the screen will look different. Look for the three horizontal bars. That is the menu. The new site is optimized for mobile devices also.

Genealogy Report for 10/1/19 SIG Meeting

The Genealogy SIG met at 7:00 p.m. at the home of Hal and Gretchen Kelley.

Those attending were: Don Rhodes, Susan Mueller, Hal Kelley, Tim Donlin, Bill Klauk, Janice Castro, Joanne Haulik, Carole Blakeslee, Connie Edwards, Liz Wisniewski, Carl Zalewski, Barbara Protzman, Doretha Christoph, Lucia Doyle, Shannon Zuck, Pat Mickel and John Szympruch.

Hal Kelley talked with the SIG about passing on to someone else the opportunity of hosting the Genealogy SIG meetings. He and Gretchen have been privileged to host the meetings since February, 2013. He said it has been a fun experience for them. He thanked Sue Mueller for hosting when the Kelleys were not available. He said that he and Gretchen will host the November meeting and the January and February, 2020 meetings. Sue Mueller will host the December, 2019 meeting. The hope is that the March, 2020 SIG meeting will be in the new place. This plan gives the SIG sufficient time to make suitable arrangements for a site for future SIG meetings. A committee of three volunteered to develop a plan: Janice Castro, Sue Mueller and Shannon Zuck.

Sue Mueller has been exploring the new "MyTreeTags" option on Ancestry.com. She gave a presentation on the subject. MyTreeTags are labels that can be attached to people in your tree. Once tags are attached, they can be used as filters when searching in your tree. Because this feature does not integrate with Family Tree Maker, only those who use ancestry exclusively will probably want to use them. FTM users should just create a new fact type, as this feature does carry over to ancestry. Ancestry also allows you to feature custom facts. MyTreeTags is a new feature that Ancestry rolled out at their conference in February. It was in Beta then, but everybody liked it, so it became a feature in May.

Sue mentioned that those who are interested in things that Ancestry.com is doing in Beta can go to "Extras" on their home page and slide down to "Ancestry Lab."

Carl Zalewski has been working on finding ships that brought his grandparents and great grandparents to America. He described his journey. "My goal was to find four different ships on which my grandparents and great grandparents migrated to America, as well as the ship my grandfather came back on from World War I. After finding each of their ship Manifests of the ports of departure and arrival, I entered what I thought was their ship in Google search, then SteveMorse.org, then Cyndi's List.com (cyndislist.com). Because everything was hand written and I was guessing the spelling, it kept coming up as unknown. I decided to google all ships that entered each port of my family's arrival (1000 pages). From there I narrowed the search to year, month, then week. Finally I found the ships name, correct spelling, as well as the owner and flag they flew under. I entered the ship name and owner and

found pictures and complete history of each ship. For my grandfather's return from WWI, it was much easier. Having information from looking up his military records, I went to the Erie Library and found a book on WWI on 80th Division and it had all the information and pictures. I now have a new appreciation of what they went through to get here. There might be an easier way of looking up this information, but I'm learning a lot of ways to dig for information. I will confess I have spent more time at the library in the last six months than I have in the last sixty years. I have to thank our great Erie Library Heritage Room and Sue Mueller's classes."

It was pointed out that when searching for information on ships, manifests, etc., it is best to use <u>SteveMorse.org</u> or the Ellis Island site. Both of these require that you set up accounts, but there is no cost.

Janice Castro reminded the SIG that the Christmas/Holiday CUE Dinner will be on Thursday, December 5th, at the Elks Club at 2409 Peninsula Dr. Reminder e-mails will be going out to everyone. Reservations should be in by the middle of November.

Sue Mueller clarified for us for answers to several questions, that the genealogical standard for records to become public is 50 years for a death certificate and 105 years for a birth certificate. However, the actual time varies from state-to-state and is not consistent or necessarily aligned with the genealogical suggestion. Some states like PA make at least an index available publicly, using the above standard or some other standard they have chosen. The only national standards Sue knows of are 72 years for a census, and 62 years after discharge for military records. They are both by law.

The next Genealogy SIG meeting will be on Tuesday. November 5th at 7:00 p.m. at the Kelleys' home.

The Meeting was adjourned at 9:00 p.m.

Smartphone & Tablet Report for 10/28/19 SIG Meeting

This Special Interest Group meets at 7:00 PM on the fourth Monday of the month at my home.

One member submitted a question about what browsers could be used in iOS as alternatives to Safari. First we described the Apple requirements that any browser available on the App Store must use the same rendering engine and layout engine as Safari. So the code that generates a web page from the server you contact is the same for each browser. Popular browsers like Chrome and Firefox are thus not the same in iOS as their namesakes on Android, Windows, or even Mac OS since each of those browsers has their own rendering and layout engines on those platforms. In addition, one cannot change default browsers in iOS; Safari is the only default browser available. Click on a link on any device using iOS and Safari will open the web page.

What is different on the alternative browsers is how they handle privacy and security. Few third party extensions are available on the App Store, but some of the alternative browsers incorporate, as part of the browser, ad blocking, cross site tracking restriction and secure connection required when available. Firefox, Duck Duck Go and Brave are browsers known for their emphasis on security and privacy. Firefox Focus is a leaner version of Firefox that is centered on privacy and can be used as a content blocker on Safari (see Settings/Safari/Content Blocker). Chrome may be the most popular browser, but Google has a reputation for acquiring and using your information and not for privacy or ad blocking. The major browsers such as Safari, Firefox and Chrome all offer the

ability to sync across devices so that bookmarks, etc. are available to you on any platform if all are logged in to the proper account. I find this extremely useful and would not use a browser that does not offer it.

Apple brought improvements to Safari in iOS 13 that I think justifies its choice over the other browsers mentioned. Privacy and security features have been enhanced. The website view menu (AA to the left of the URL) includes Show Reader View, Hide Toolbar, Request Desktop Website, and Website Settings. The latter allows access to camera, microphone and location to be chosen for that website. The global choice is still available in Settings. The share sheet now permits one to choose how a site can be included in an email (link, PDF, Reader View). Tabs can be closed automatically on a time schedule rather than just manually. Screen shots have the option to include the entire web page rather than just what vou see on the screen. A new download manager lets you choose where to save your downloads.

We spent some time on Sign In With Apple. Some apps and websites that require a username and password have offered the alternative of using your Google, Facebook or Twitter accounts instead of generating new credentials for each site. While that may seem convenient, there are hazards that a YouTube video by the Wall Street Journal illustrate:

of 2020 all App Store apps that offer Sign In With Google, Facebook or Twitter must offer Sign In With Apple.

We then went through a number of miscellaneous significant changes introduced in iOS 13. System wide Dark Mode may take some getting used to, but it does offer an alternative to the glaring phone screen that lights up your face and exacerbates eye strain. Control Center allows easy access to selecting different Wireless and Bluetooth connections by long pressing the block in the upper left of Control Center and then long pressing the Wireless or Bluetooth Symbols. Long Pressing the Brightness symbol allows you access to turn on or off Dark Mode. The App Store no longer shows an update tab, but the updates can be accessed by tapping your profile at the top right hand corner. Included in Settings/Battery is a new item for Optimizing Battery Charging that is advertised as a way to extend battery lifetime. Apparently leaving your device connected to the charger after the battery reaches 100% such as overnight charging will damage the battery over time. A sequence of tiny discharge followed by tiny charges occurs when the battery is nominally at 100% and that degrades the battery chemistry. By turning on Optimizing Battery Charging the device slows charging at 80% and, from what the device has learned of your usage habits, the charging restarts so that your battery will be at 100% when you need it. There was a lot of interest in this topic.

Find My Phone and Find My Friends has been combined into (drumroll) Find My. In

addition to the features of the apps it replaces, Find My can locate lost devices even if they have no wifi or cellular connection. The lost device emits an encrypted Bluetooth signal that is picked up by any Apple device nearby, uses the location of that device, makes its way back to Apple and then to the Find My app you are using to search for a lost item. The encryption hides locations even from Apple. (Turning off Bluetooth or power for the lost device makes it untraceable.) The encryption process involves public and private keys with the public key changing with time. Using such complex encryption together with crowd sourcing for the huge number of users of iOS 13 makes this an awesome process if it works as advertised.

User Guides for iOS 13.1 and iPadOS 13 are available through iBooks at no cost and all users of the new operating systems are encouraged to download and look through them. They are great reference manuals but make very dry reading. A more readable description of iOS 13 can be found at:

We will continue our discussion of iOS 13 on November 25. Changes to Photos, Maps, Reminders and more will be covered. See you then!


Directions to Wayside Presbyterian Church for CUE Meetings

Wayside Presbyterian Church, at 1208 Asbury Road, is approximately three blocks north of the intersection of Asbury Road and Route 5. This intersection is at the northwest corner of the Erie International Airport property. Following Asbury, turn left at the first marked driveway for the church. During the afternoon winter schedule (10:00 AM for the months of November, January, February and March), entry is through the two sets of blue double doors. Use the buzzer to gain entry if the doors are locked. During the normal evening schedule (7:00 PM the remaining months) use the double doors on the south side of the Christian Education wing. Signs are posted in the building to direct you to the meeting room.

From West of Erie International Airport: Follow Route 5 to the intersection of Asbury and Route 5. Turn hard left onto Asbury Road. Look for the church on the left approximately 3 blocks north of the intersection.

From South of Erie: Take Interstate 79 north to the 26th Street (Route 20) Exit. Bear left onto 26th Street (Route 20) west. Follow Route 20 about 3.4 miles west to Asbury Road. Turn right (at the Sheetz Gas Station) onto Asbury and follow it straight across Route 5. Look for the church on the left approximately 3 blocks north of the intersection.

From East of Erie International Airport: Follow 26th Street (Route 20) west to Asbury Road. Turn right onto Asbury and follow it straight across Route 5. Look for the church on the left approximately 3 blocks north of the intersection. OR, follow 12th Street (Route 5) west past the airport to Asbury Road. Turn right onto Asbury Road. Look for the church on the left approximately 3 blocks north of the intersection.
